to be 10 to 30 per week. He will also fulfill the role of Recreation Coordinator not to exceed 10 hours per year. Also appoint him Treasurer and Secretary of the Board. As Treasurer, W. Kelly will become the officer in control of all financial accounts per Govt. Code Section 61053. Authorize him to obtain a BCCSD credit card from Wells Fargo Bank for BCCSD operations only. G. McHugh is to retain his BCCSD credit card until W. Kelly receives his whereupon G. McHugh will return the credit card to the BCCSD and it will be cancelled.
