### 1. ROLL CALL.

### 2. PUBLIC FORUM.

### 3. Approval of minutes from previous Board Meeting.

Motion by Director Eric Wolf and seconded by Dennis Roy to approve the June 2, 2020 minutes. The motion was approved by members Levy, Speer, Roy and Lantz voting yes, and Director Eric Wolf abstaining.

5. Discussion of protocols and approvals for various community events to be paid by the Bell Canyon CSD and organized by the HOA. Jenny and Bri to present, if any. Deposits have been paid to various vendors and no refunds are permitted by some. Due to Corona-19, many events have been postponed to an unk future

## date. There needs to be an established policy for full refunds of deposits if any event is postponed to a later date of cancelled for any reason.

No presentation by the HOA. Refund policy adopted for all future events.

# 6. Discussion and update of Bell Canyon Park / Trails and a lease Agreement between the HOA and the CSD. To include all related matters including insurance and all liability concerns and issues.

Discussed the Park and Trails lease. Which Trails were discussed. Who would pay for water and utilities? Discussed the Liability issues if someone is injured. Government immunity and what is covered. If Insurance is in excess, HOA would be responsible. The park renovation would be an improvement for the Bell Canyon Community.

HOA and CSD share liability responsibility. CSD and Insurance coverage and Government immunity. After that HOA is responsible. For \$5 million -dollar policy, how much will that cost?

Motion to approve Park Lease made by Bill Speer. Seconded by Dennis Roy. Approved by Speer, Roy and Judy Lantz. Abstaining were Levy and Wolf.

## 7. Waste Management Contract is up for renewal. A committee will be established by President Levy to review the contract.

Speer and Zine will work with Waste Management and present a contract to the CSD Board.

# 8. ADA Website and compliance with new state regulations. Who will manage this activity and what is the cost.

Judy Lantz will coordinate and be responsible for the Website. The cost for the connection is \$1,200 a year.

### 9. Approval of the Annual 2019-2020 Certified CSD Audit and payment to Auditor Lichter Yu.

Motion to approve by Eric Wolf and seconded by Judy Lantz. All voted to approve the motion. The cost will be between \$5,000 and \$6,000.

# 10. Bell Canyon Road is finally paved. A Thank You letter will be sent to L.A. City Councilman John Lee. The CSD sent a formal letter to Councilman Lee requesting that the road be paved.

### 11. Amend the 2020-2021 budget.

Motion by Richard Levy and seconded by Dennis Roy to add \$5,000 to outside services. The motion passed without opposition.

## 12. Approval of President Levy for maximum expenditure amount without prior Board approval.

Motion by Dennis Roy and seconded by Bill Speer to increase authority to \$3,500. The motion passed without any opposition.

### 13. Discussion and approval of charges from the BCA-HOA to the CSD.

Matters to be resolved with Levy and Wolf.

# 14. CSD General Manager becomes a Bell Canyon CSD employee. New Calif State Law. Salary and Benefits and associated factors.

Dennis P. Zine will become an "employee" which will require certain changes including Work Comp Ins and other required benefits.
